RESOLUTION NO. 14, S' 2019
RESOLUTION TO TEMPORARILY STOP THE APPLICATION OF WATER
CONNECTION OF THOSE WHO DESIRES TO OPERATE BUSINESS IN WATER
REFILLING STATION

WHEREAS, the Mangaldan Water District's main objective is to provide water supply in the municipality of Mangaldan;

WHEREAS, the Mangaldan Water District has a total number of thirty seven (37) owners and/or operators of water refilling stations in the municipality as of this date;

WHEREAS, the owners and/or operators of water refilling stations are mandated to submit certificate of potability from the Water District as one of their prerequisite to start and continue its operation;

WHEREAS, with that alone is a clear evidence that they are making business out of the water the District produces from its deep wells;

WHEREAS, these water refilling stations in the municipality are selling bottled and gallon water at higher prices compared to what the District gives to its consumers;

WHEREAS, it has been observed that during peak hours, the Water District is experiencing low water pressure, some could be caused by the drawing of water by these refilling stations to fill their tanks for their businesses, thus the consumers of the District are left with low water supply;

WHEREAS, Mrs. Marilou Gavino was asking for certificate of potability from the office for the purpose of the business for water refilling station prior to this approval;

NOW, THEREFORE, on motion of Dir. Teresita G. Cera duly seconded by all the members present, it was:

RESOLVED, as it is **HEREBY RESOLVED**, that the application for water connection for the use of refilling stations be stopped effective August 1, 2019.

RESOLVED FURTHER, that certificate of potability be issued to Mrs. Marilou Gavino and will be considered because she verbally signified her intention to apply for her connection prior to this approval subject to the terms and conditions as specified in the contract of lease with her LESSEE “xxx7. That the LESSEE is only allow to process their water product from 1:00 o’clock in the afternoon up to 9:00 o’clock in the evening xxx”(copy of the contract between Mrs. Gavino and Mr. Rogelio dela Fuente is hereto attached and be made as integral part of this Resolution)

TO OUR VALUED CONSUMERS:

Good day!!!

Please be informed that under paragraph O, Section 27 of Chapter 5 of the **Republic Act 9275 otherwise known as the “Philippine Clean Water Act of 2004** *“Directly using booster pumps in the distribution system or tampering with the water supply in such a way as to alter or impair the water quality is strictly prohibited.”*

Be reminded that under Section 28 of the said Act, clearly states that:

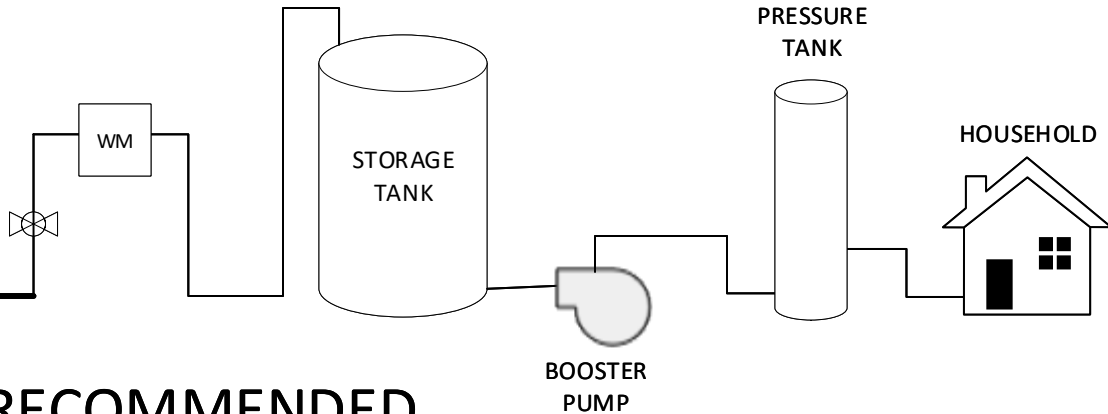
“xxx any person who commits any of the prohibited acts provided in the immediately preceding section or violates any of the provision of this Act or its Implementing Rules and Regulations shall be fined by the Secretary, upon the recommendation of the PAB in the amount of not less than Ten Thousand Pesos (P10,000.00) nor more than Two Hundred Thousand Pesos(P200,000.00) for every day of violation xxxx”

With this, anyone who gets caught using booster pumps directly in the mainline in their residential and/or commercial connection will be held liable and will be meting the above-mentioned penalty.

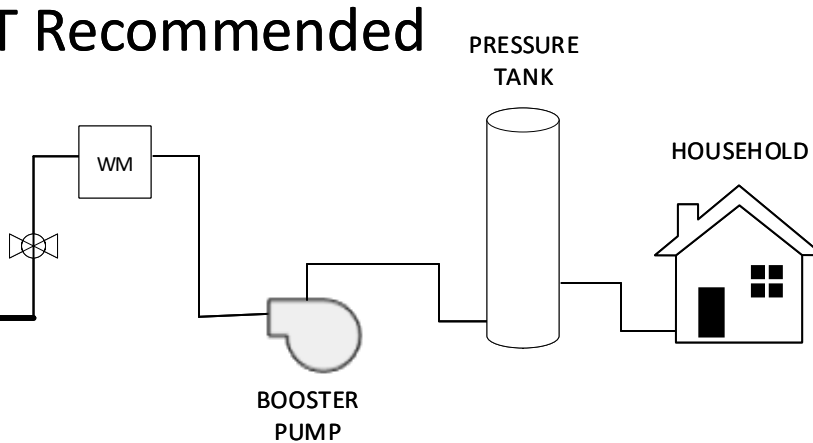
