Description

INVITATION TO BID FOR SUPPLY AND DELIVERY OF ONE (1) UNIT FORWARD TRUCK WITH WATER TRUCK BODY AND SINGLE AIR CONDITIONER

The Mangaldan Water District, through the MAWAD Corporate Fund CY 2024 intends to apply the sum of Four Million Pesos (P 4,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply and Delivery of One (1) Unit Forward Truck with Water Truck Body and Single Air Conditioner/MAWADGOODS#17, S. 2024. Bids received in excess of the ABC shall be automatically rejected at bid opening.

1. The Mangaldan Water District now invites bids for the above Procurement Project. Delivery of the Goods is required by Thirty (30) calendar days. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

3. Prospective Bidders may obtain further information from the Mangaldan Water District and inspect the Bidding Documents at the address given below from 9:00 A.M. – 11:00 A.M. and 2:00 P.M. – 4:00 P.M.

The Procuring Entity shall allow the bidder to present its proof of payment for the fees

to the authorized Teller assigned at the Paying Section of MAWAD.

5. The Mangaldan Water District will hold a Pre-Bid Conference on December 06, 2024 at 2:00 P.M. at the G/F Conference Room of the Mangaldan Water District, Serafica St., Mangaldan, Pangasinan, which shall be open to prospective bidders who purchased Bidding Documents.
6. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before 2:00 P.M. of December 18, 2024. Late bids shall not be accepted.
7. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
8. Bid opening shall be on December 18, 2024 at 2:00 P.M. at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity that will be limited to at least two (2) representatives per company/agency.
