- The Mangaldan Water District, through the MAWAD Corporate Fund CY 2024 intends to apply the sum of Three Million Two Hundred Fifty Nine Thousand Two Hundred Thirty Five Pesos & 50/100 (P 3,259,235.50) being the Approved Budget for the Contract (ABC) to payments under the contract for the Drilling of One (1) Exploratory/Production Well at Barangay Bari/MAWADWORKS#1, S. 2024. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The Mangaldan Water District now invites bids for the above Procurement Project. Completion of the Works is required for Sixty (60) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before 2:00 P.M. of March 6, 2024. Late bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.

9. Bid opening shall be on March 6, 2024 at 2:00 P.M. at the Mangaldan Water District, Seráfica St., Mangaldan, Pangasinan. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity that will be limited to one (1) representative per company/agency.
